Festival venues include: children's activities, petting zoo, clowns, kiddie rides, Annual Car Show, Antique Tractor Show, Farmer's Market, Antique Alley, carriage rides, and over 150 vendors! Back for a third year is the Motorcycle Show that drew entries from all over the region last year. This event is publicized through radio, print, newsletters, web sites and a very popular event tabloid delivered to thousands of households.

### **VENDOR CHECK-IN**

Vendors who register by the due date will receive a vendor pass and a map showing your space number by approximately October 10, 2010. Vendors will check in beginning at **6:30 a.m.** on the day of the Harvest Festival. All vendors will receive specific instructions for their individual check-in times and vendor space numbers. Please place your vendor pass in your vehicle windshield. Only **1 vehicle** per space will be allowed through the check-in point. This pass will admit you past the roadblocks during your SCHEDULED check-in time. **PLEASE DO NOT LOSE THIS PASS and DO NOT MISS YOUR SCHEDULED CHECK-IN TIME.** After that time you may still set up a booth, but **NO** private vehicles will be admitted and you will have to carry your booth supplies to the Festival area. **At 4 p.m. all vendors will have 1 hour to dismantle their booth and be off the street. The streets will reopen at 5:30 p.m.**

**EARLY CHECK-IN for Food Vendors only:** *Food vendors are encouraged to check in on Friday if possible.* Please indicate that you require early check-in on the registration form and check in at Town Hall, 117 Butler Street, between 3:00 p.m. and 5:00 p.m. on Friday. Special set up of food vendors will only be allowed after 6:30 p.m. Friday evening in designated areas. Food vendors must comply with applicable Health Department regulations. Please contact the Health Department at (540) 899-4797 for your permits. Contact them early, since there is a processing period in order to receive your permits. Remember, it is your responsibility to contact them. Your booth will be inspected that morning by the Health Department before the Festival starts!

**\*All vendors must be registered to participate. Bring your own tents, tables, chairs, etc. NO ELECTRICITY WILL BE PROVIDED.**
